

# MIAMI BEACH RISING ABOVE

## Indian Creek Drive Flooding Mitigation Phase III

*Project Advisory - May 3, 2021*

### Project Overview and Benefits

This project delivers vital improvements to the Indian Creek Drive community by providing new sidewalks, a lighting system and a continuous delineated bicycle path. It will also address flooding within the neighborhood by installing a comprehensive stormwater drainage system, including a water treatment system and generator in case of a power outage. Additionally, the road and sidewalk will be rebuilt at a higher elevation to mitigate sea level rise.

### What's Happening

For your safety, please do not enter work zones.

To reduce the overall time impact to the project and expedite the work, a change order for additional work has been awarded to the contractor.

A revised traffic pattern along Collins Avenue between 26 and 41 streets will be implemented. More information will be included in future updates.

To assist motorists, a flag person will be present during work hours at the intersection of 41 Street and Collins Avenue. An off-duty police officer will also be present in the project corridor.

The following activities are scheduled along Indian Creek Drive and side streets:

- Installation of sheet pile wall, which includes the use of a crane, at various locations along the west side of the project corridor. Please be advised of the potential for increased noise during this work.
- Installation of concrete test pile, which includes the use of a crane and pile driving hammer, along the west side of Indian Creek Drive between 31 and 32 streets. Please be advised of the potential for increased noise during this work.
- Constructing sections of barrier wall between 34 and 37 streets.

Harmonization work has been completed in the area north of 31 Street to 40 Street. Harmonization work continues between 40 and 41 streets.

Please note, the project team is closely monitoring the situation surrounding COVID-19. The contractor is enforcing strict social distancing measures and employees are required to wear face coverings while on-site, including breaks.

### Timeline

The project started in March 2020 and is expected to last approximately two years. Construction work hours are weekdays from 8 a.m. to 6 p.m. Extended time is subject to city approval and community notification. Please note, this schedule may change due to weather or unforeseen circumstances.

### What to Expect



- Moderate levels of construction noise is expected during the day.
- Construction equipment, machinery and workers will be present in work zones.

An advisory will be issued every two weeks or as changes warrant.
