Indian Creek Drive Flooding Mitigation Phase III

Traffic Plan Update - May 12, 2021

Project Overview and Benefits

This project delivers vital improvements to the Indian Creek Drive community by providing new sidewalks, a lighting system and a continuous delineated bicycle path. It will also address flooding within the neighborhood by installing a comprehensive stormwater drainage system, including a water treatment system and generator in case of a power outage. Additionally, the road and sidewalk will be rebuilt at a higher elevation to mitigate sea level rise.

What's Happening

Beginning on Friday, May 14, a revised traffic pattern along Collins Avenue between 26 and 41 streets will be implemented. As part of the new traffic pattern, Collins Avenue will accommodate two-way traffic from 26 to 41 streets and Indian Creek Drive will be closed. Traffic signage, barricades and temporary signals on Collins Avenue will be installed as part of the extended traffic plan. Ingress and egress for surrounding properties will be maintained throughout this process. Pedestrian crossings will be installed throughout the corridor as well as U-Turn opportunities at certain locations.



On the evening of Thursday, May 13, Collins Avenue from 26 to 41 streets will switch to two-way traffic and Indian Creek Drive will close. Each building will continue to have access as discussed in the meetings between the city and property representatives.

North facing parking spaces on the west side of Collins Avenue between 26 and 31 streets will be temporarily removed and later reestablished as southbound parking spaces.

Timeline

The project started in March 2020 and is expected to last approximately two years. Construction work hours are weekdays from 8 a.m. to 6 p.m. Extended time is subject to city approval and community notification. Please note, this schedule may change due to weather or unforeseen circumstances.

What to Expect

- Moderate levels of construction noise is expected during the day.
- Construction equipment, machinery and workers will be present in work zones.
- Temporary parking restrictions on the west side of Collins Avenue from 26 to 31 streets.
- Traffic signage, barricades and temporary signals will be installed on Collins Avenue.
- Businesses should consider having large deliveries utilize the side streets and avoid delivering on Collins Avenue.
