Indian Creek Drive Flooding Mitigation Phase III

Project Advisory - July 30, 2021

Project Overview and Benefits

This project delivers vital improvements to the Indian Creek Drive community by providing new sidewalks, a lighting system and a continuous delineated bicycle path. It will also address flooding within the neighborhood by installing a comprehensive stormwater drainage system, including a water treatment system and generator in case of a power outage. The road and sidewalk will be rebuilt at a higher elevation to mitigate sea level rise.

What's Happening

As part of a recently implemented traffic pattern, Collins Avenue now accommodates two-way traffic between 26 and 41 streets. Indian Creek Drive is closed. Traffic signage, barricades and temporary signals on Collins Avenue have been installed as part of the extended traffic plan. Ingress and egress for surrounding properties will continue to be maintained. Pedestrian crossings have been installed throughout the corridor as well as U-turn opportunities at certain locations.

For your safety, please do not enter work zones.

Motorists with Zone 6 residential parking permits may use the P56 and P57 parking lots during construction.

The following activities are scheduled along Indian Creek Drive and side streets:

- Erection of a traffic signal, light poles and signage along Indian Creek Drive.
- Installation of underground drainage pipes and structures along Indian Creek Drive between 31 and 27 streets.
- Beginning the week of August 9, workers will pave the west side of Indian Creek Drive between 39 and 41 streets.

Harmonization continues between 26 and 30 streets. Each property is responsible for regular maintenance of trench drains installed on private property to ensure proper drainage.

This schedule may change due to unforeseen conditions or inclement weather.

Timeline

The project began in March 2020 and is expected to last approximately two years. Construction work hours are weekdays from 8 a.m. to 6 p.m. Extended time is subject to city approval and community notification. This schedule may change due to weather events or unforeseen circumstances.

What to Expect

- Moderate levels of construction noise can be expected during the day.
- Construction equipment, machinery and workers will be present in work zones.

An advisory will be issued every two weeks or as changes warrant.
