Judge Cuervo convened the meeting at 10:00 a.m.

#### I. Canvassing of Vote-by-Mail and Provisional ballots

Jean Olin, Outside Counsel, notified the Canvassing Board that the Supervisor of Elections is required to notify a voter as soon as it is practical if a voter's signature is missing or does not match the one on record. Once a voter learns about the missing or mismatched signature, the voter may complete, sign, and return a Vote-by-Mail Ballot Cure Affidavit with a copy of identification (ID). The deadline to submit the form and the ID is no later than 5:00 p.m. on the 2nd day after the election. Ms. Olin reiterated that the Vote-by-Mail Cure Affidavit must be signed by the voter. If the signature on the Affidavit does not match the one on record, but the Voter has provided a Tier 1 ID the Canvassing Board may accept the Vote-by-Mail Ballot.

Clerk's Note: Tier 1 identification is defined as a current and valid ID that includes the voter's name and photograph: Florida driver license; Florida identification card issued by the Department of Highway Safety and Motor Vehicles; United States passport; debit or credit card; military, student, retirement center, neighborhood association, or public assistance ID; veteran health ID card issued by U.S. Department of Veterans Affairs; Florida license to carry a concealed weapon or firearm; or employee ID card issued by any branch, department, agency, or entity of the Federal Government, the state, a county, or a municipality.

Ms. Olin explained that a ballot of a person casting a provisional ballot shall be counted unless the majority of the Canvassing Board determines by a preponderance of the evidence that the person was not entitled to vote.

Robert A. Rodriguez, Assistant Deputy Supervisor, Miami-Dade Elections, notified the Canvassing Board that 48 Vote-by-Mail ballots had been compiled by the Vote-by-Mail Section, of which 33 were deemed valid by the Miami-Dade Elections Department and 15 were presumed invalid and had to be canvassed by the Canvassing Board.

The alleged deficiencies for said Vote-by-Mail ballots are:

Mr. Rodriguez explained to the Canvassing Board that 15 of the 48 Vote-by-Mail ballots had no signature. The Canvassing Board reviewed each of the 15 Vote-by-Mail ballots to confirm the lack of signature. The Canvassing Board unanimously rejected the 15 Vote-by-Mail ballots with no signatures. The 15 Vote-by-Mail ballots were marked across the face of the envelope "Rejected as Illegal" by Judy Hoanshelt.

Mr. Rodriguez stated that on November 16, 2021, the Canvassing Board unanimously "soft rejected" 10 Vote-by-Mail ballots, as not matching the signature in the voter registration system beyond a reasonable doubt. He added that no Cure Affidavit had been received for the 10 "soft rejected" ballots.

The Canvassing Board unanimously agreed to reexamine the 10 "soft-rejected" ballots. Judge Cuervo moved to reconsider one of the previously "soft rejected" ballots. Ms. Hoanshelt and Mr. Granado agreed to reconsider the original rejection. The Canvassing Board reviewed the signature on the ballot against the signature in the voter registration system. Judge Cuervo stated that he opined that the signature on the ballot matched what was in the system. Ms. Hoanshelt and Mr. Granado disagreed. Thus, the ballot was rejected by a majority of the Canvassing Board beyond a reasonable doubt. The remaining 9 "soft rejected" ballots were unanimously rejected by the Canvassing Board as not matching the signature in the voter registration system beyond a reasonable doubt. The 10 Vote-by-Mail ballots were marked across the face of the envelope "Rejected as Illegal" by Ms. Hoanshelt.

Robert A. Rodriguez, Miami-Dade Elections, notified the Canvassing Board that 2 Provisional ballots had been compiled by the Registration Section, both of which were deemed valid by the Miami-Dade Elections Department.

Mr. Rodriguez explained to the Canvassing Board that the 2 presumed valid Provisional ballots were from voters who did not bring ID when they voted at the precinct on Election Day. These 2 voters cast Provisional ballots. The signatures on the 2 Provisional ballots match the signature in the voter registration system. The 2 Provisional ballots were unanimously accepted by the Canvassing Board as matching the signature in the voter registration system. The 2 Provisional ballots were marked across the face of the envelope "Accepted as Legal" by Ms. Hoanshelt.

#### II. Certification of Official Results

Mr. Rodriguez presented the Canvassing Board with the Official Results of the November 16, 2021 Run-Off Election (including Vote-by-Mail and provisional ballots). The members of the Canvassing Board accepted and signed the result copies. (See attached Exhibit "A.")

#### III. Race and Precinct Selection for Manual Post-Election Audit

Judge Cuervo, in the presence of Ms. Hoanshelt, Mr. Granado, and Mr. Rodriguez threw dice to randomly select the race and precinct that would undergo a manual post-election audit. The Group I Race in Precinct 015.0 (Normandy Shores Golf Club) was randomly chosen for the manual post-election audit to be conducted on November 22, 2021.

#### IV. Certification of Election Tabulation

See Certification of Election Tabulation attached and incorporated hereto as Exhibit "B."

Name Badges - Florida Statute 102.141(9) requires that each member, substitute member, and alternate member of the Canvassing Board and all clerical help must wear identification badges during any period in which the Canvassing Board is canvassing votes or engaging in other official duties. The identification badges should be worn in a conspicuous and unobstructed area and include the name of the individual and his or her official position. Judge Raul Cuervo, Rafael E. Granado, Judy Hoanshelt, and Jean Olin wore their identification badges while engaging in their official duties.
