

2019 SCHEDULE OF LAND USE BOARD MEETINGS AND TRANSPORTATION DEADLINES

All meetings are held in the Commission Chambers, Third Floor, Miami Beach City Hall unless otherwise noticed. Please note that only complete applications are scheduled for consideration by Land Use Boards and the number of applications placed on an agenda may not exceed 15 in order to allow sufficient time for the applicants to present, and the board to duly consider each item during the scheduled meeting. Complete applications will be scheduled for the next available agenda on a first come – first serve basis unless the applicant requests to be scheduled on a future agenda. The timeline represented herein may be extended if application is incomplete or submittals not made on a timely manner.

Applications requiring a traffic study must meet with, Transportation, and peer reviewer Thirty (30) days prior to First submittal deadline to determine the methodology for the traffic impact study and obtain Transportation Department's requirements check list.

Fifteen (15) days before First submittal: applicant must submit the traffic study via CAP.

Seven (7) days prior to First submittal: Transportation Department/Peer Reviewer will provide first round of comments to the applicant.

Applicant must address comments and submit revised traffic study/plans for CAP First submittal deadline including a narrative responding to Transportation/Peer Reviewer comments.

Please note, submittals are due at 12:00 (noon) on the deadlines listed below.
