Meeting commenced at approximately 1:11 p.m.

1. Approval to Commence Vote-by-Mail ballot opening, processing, and duplication.

Action:

- a. The Miami Beach Run-Off Election Canvassing Board, composed of Raul Cuervo, County Judge; Rafael E. Granado, City Clerk; and Judy Hoanshelt, Miami Beach Elector, authorized the Miami-Dade Elections Department staff to commence the Vote-by-Mail opening, duplicating, and processing. See Authorization Form.
- b. The Miami Beach Run-Off Election Canvassing Board witnessed the opening and sorting of the Vote-by-Mail ballots by the Pitney Bowes high-speed Vantage letter sorter.

2. Vote-by-Mail ballot Opening and processing.

Action:

- a. Miami-Dade Elections staff, in the presence of the Miami Beach Run-Off Election Canvassing Board, opened 2,669 Vote-by-Mail returned envelopes. One of said envelopes, when opened, did not contain a ballot.

3. Duplication of ballots.

Action:

- a. Miami-Dade Elections staff duplicated 1 damaged ballot. The correctness of the duplicated ballots was reviewed and approved by the Miami Beach Run-Off Election Canvassing Board.

4. Pre-Count Logic and Accuracy Test of the optical scan voting system used for Vote-by-Mail and Provisional Ballots.

Action:

- a. The Miami Beach Run-Off Election Canvassing Board verified that the optical scan voting equipment counts were at a "zero count." The optical scan voting machines reset to zero were machines 8518110383 (hereinafter referred to as # 3) and 8518090379 (hereinafter referred to as # 9).

Miami-Dade Elections staff started to process the 2,668 Vote-by-Mail ballots received.

Thereafter, optical scan voting machine # 3 started to jam/malfunction. Optical scan voting machine 8518090376 (hereafter referred to as # 6) was substituted for optical scan voting machine # 3.

The Miami Beach Run-Off Election Canvassing Board verified that optical scan voting machine 6 was at "zero count."

The processing of the ballots continued to conclusion utilizing optical scan voting machines # 6 and # 9. See attached Precincts Processed Report.




