Judge Cuervo convened the meeting at 10:07 a.m. on November 22, 2019.

I. Canvassing of Vote-by-Mail and Provisional Ballots.

A. Ingrid Miranda, Miami-Dade County Elections, presented to the Canvassing Board 5 provisional ballots. The Canvassing Board proceeded to review the 5 Provisional Ballots, and took the following action:

- The Canvassing Board accepted as legal 3 provisional ballots that had been presumed valid by the Elections Department.
- The Canvassing Board rejected as illegal 1 provisional ballot for a voter that was not registered.
- The Canvassing Board rejected as illegal 1 provisional ballot for a voter that registered after the book closing.

- B. Ms. Miranda, presented to the Canvassing Board 25 Vote-by-Mail ballots with no signatures for which a cure affidavit had not been received. These 25 Vote-by-Mail ballots without signatures had received “soft rejects” by the Canvassing Board on Election Night, November 19, 2019. The Canvassing Board once again reviewed the 25 Vote-by-Mail ballots without signatures, and unanimously rejected as illegal all 25 Vote-by-Mail ballots with no signatures.
- C. Ms. Miranda, presented to the Canvassing Board 1 Vote-by-Mail ballot for which a cure affidavit had been received. The cure affidavit was not signed and failed to include the required identification. The Canvassing Board reviewed the cure affidavit, and unanimously rejected as illegal the Vote-by-Mail ballot for failing to include a signature and an identification.
- D. Ms. Miranda, presented to the Canvassing Board 13 Vote-by-Mail ballots for which a cure affidavit had been received. The signatures on the 13 cure affidavits did not match the signatures on file with the Elections Department. The Canvassing Board reviewed the 13 cure affidavits, compared the signatures on the cure affidavits with that on file, unanimously determined that the signatures did not match those on file, and rejected the 13 Vote-by-Mail ballots as illegal.
- E. Ms. Miranda, presented to the Canvassing Board 1 Vote-by-Mail ballot for which a cure affidavit had been received. The cure affidavit was signed but the signature did not match the signature on file with the Elections Department. The affidavit also failed to include the required identification. The Canvassing Board reviewed the cure affidavit, compared the signature, and unanimously rejected as illegal the Vote-by-Mail ballot for failing to include an affidavit and for the signature not matching the signature on file.

Ms. Miranda presented to the Canvassing Board the Official Results of the November 19, 2019 Run-Off Election (including Vote-by-Mail and provisional ballots). The members of the Canvassing Board accepted and signed the result copies.

III. Post-Count Logic and Accuracy Test of The Optical Scan System Used For Vote-By-Mail and Provisional Ballots.

Action: The post-count Logic and Accuracy Test of the optical scan system used for Vote-y-Mail and Provisional Ballots was conducted.

IV. Race and Precinct Selection for Manual Post-Election Audit

Raul Cuervo, County Court Judge, in the presence of City Clerk Granado, Ms. Hoanshelt, Ms. Miranda, and Ms. Prieto threw dices to randomly select the race and precinct/polling place that would undergo a manual post-election audit. The Group IV Race in Precinct 020.0 was randomly chosen for the manual post-election audit to be conducted on November 25, 2019.

Name Badges - A new State Statute requires that each member, substitute member, and alternate member of the Canvassing Board and all clerical help must wear identification badges during any period in which the Canvassing Board is canvassing votes or engaging in other official duties. The identification badges should be worn in a conspicuous and unobstructed area and include the name of the individual and his or her official position. Judge Raul Cuervo, Rafael E. Granado, and Judy Hoanshelt, Jean Olin,

Regis Barbou, and Jimmy McMillion wore their identification badges while engaging in their official duties.

I, the undersigned, Rafael E. Granado, City Clerk of the Miami Beach do by my signature hereto, certify that to the best of my knowledge:

1. On November 5, 2019, commencing at approximately 7:00 p.m. the Miami-Dade County Supervisor of Elections had the absentee ballot tabulating equipment tested to ascertain that the equipment will correctly count the votes cast for the candidates and/or issues, which have been voted in the Miami Beach General and Special Elections, held on November 5, 2019.

2. The testing materials of the Public Test, delivered still under Seal No. 0051592, opened in my presence, were used and the procedures of Paragraph Two, Certification of Logic and Accuracy were followed.


3. At the completion of the above test all counters were zeroed, and all votes cast in the above election were counted. Steps have been taken to ensure the security of said materials prior to, during and subsequent to the election, except when said materials were properly in the possession of the Elections Department staff appointed to conduct the election.

4. Except as otherwise specifically set forth and declared in this certification, in our presence and sight, no absentee ballot was removed from or added, and no absentee ballot was in any manner altered or tampered with by any person, and no person touched any absentee ballot or PEB, except a person authorized to do so pursuant to Section 101.5612, Florida Statutes.


