

## MIAMI DADE – FILM & PRINT PERMIT JURISDICTIONS

The City of Miami, Miami Dade County and the City of Miami Beach are 3 different entities that service different areas under sometimes similar but often varying guidelines.

### **To which agency should I submit my application?**

The borders of the municipalities they service determine the jurisdiction of each permitting agency. Please refer to the [Miami Dade County Municipalities Map](#).

### **City of Miami Beach:**

Only processes permits for production activity within Miami Beach. [City of Miami Beach Zoning Map](#)  
Productions may choose to apply using the County's Permitting System or the City of Miami Beach's permitting system.

### **City of Miami:**

Only processes permits for production activity within the City of Miami. [City of Miami Zoning Map](#)  
Productions may only apply through the City of Miami's permitting system (not the County System)

### **Miami Dade County Office of Film & Entertainment:**

The county processes permits for all locations within unincorporated Miami Dade, as well as the following municipalities: Town of Cutler Bay, City of Doral, Village of El Portal, Florida City, City of Hialeah, City of Hialeah Gardens, City of Miami Gardens, Town of Miami Lakes, City of Miami Springs, City of North Miami Beach, North Bay Village, Village of Palmetto Bay, City of South Miami.

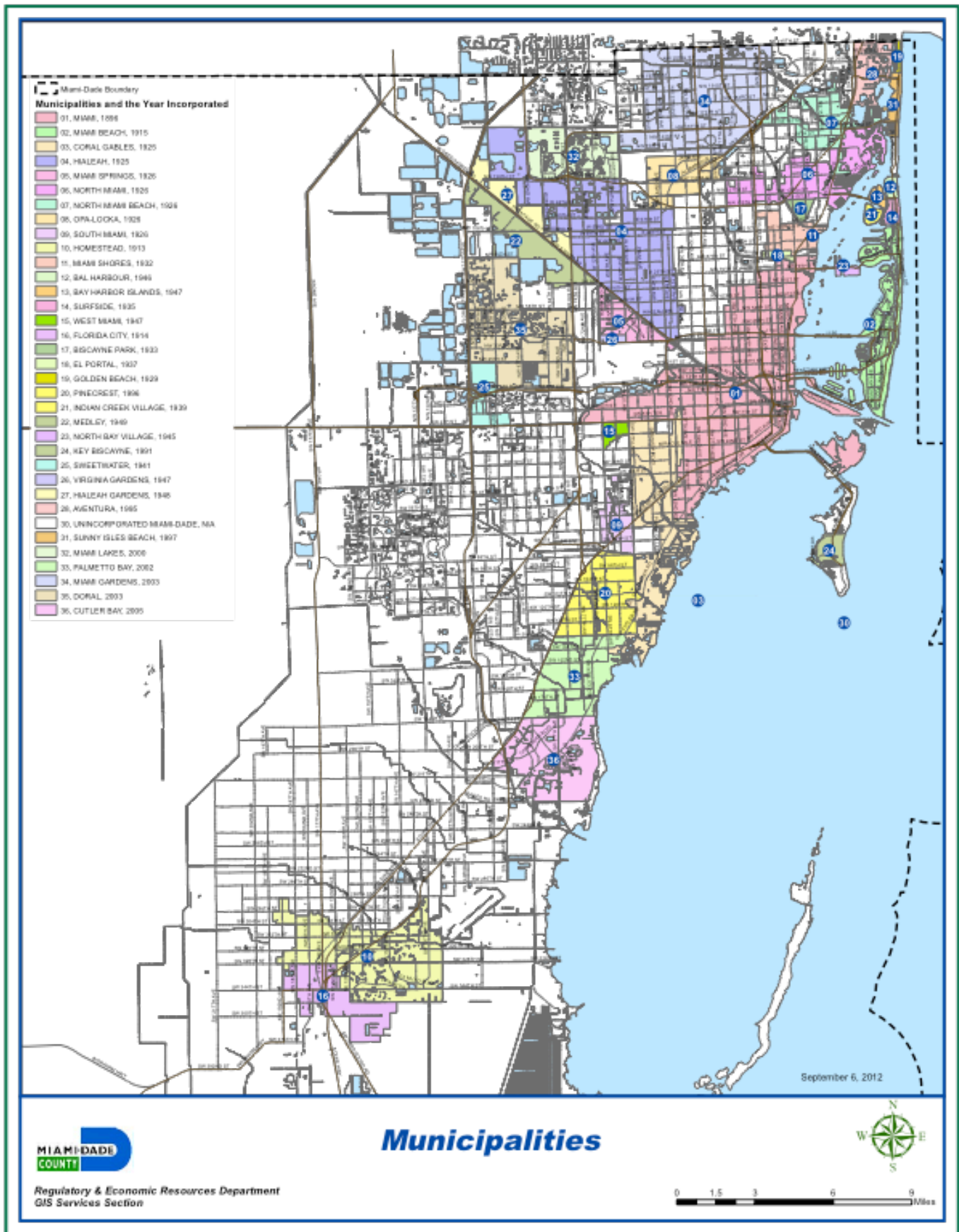
