Subject: Prekindergarten Pilot Program Lottery Results and Next Steps

The purpose of this Letter to Commission is to update you on the status of the City of Miami Beach's Prekindergarten (PreK) Pilot Program for Miami Beach residents for the 2021-2022 school year, approved at the July 29, 2020 Commission meeting. The Prekindergarten Pilot Program will expand hourly access to high quality PreK providers by providing up to \$2,700 to eligible Miami Beach families.

A computerized lottery was held on Tuesday, January 5, 2021 to place all resident applicants in a numerical order for stipend receipt. Results from the lottery have been posted on the City's website including family name, confirmation number, and lottery number (Attachment A). There are 106 Miami Beach residents who submitted applications to receive the PreK stipend of which approximately 92 will be selected. There are currently eighteen (18) Prekindergarten provider partners (Attachment B) who registered to join the City in its effort to expand access to quality early childhood education.

The PreK website located at www.miamibeachfl.gov/prek provides an overview of the program, lottery results, and provider information (Attachment C). Staff from the Office of Organizational Development Performance Initiatives (Education) will contact family applicants over the next several weeks in the order of selection by the computerized lottery process to verify residency and child age until all funds are exhausted.

Additionally, the administration held several informational sessions for interested Miami Beach families and PreK providers from September through December 2020. Miami Beach providers were also contacted directly to inform them of this opportunity.

We will continue to support our vision of being a prosperous city with a special flavor of arts, culture, education, and business with management objectives of being known for (K-12) educational excellence.

PREKINDERGARTEN PILOT PROGRAM 2021-2022

The City of Miami Beach has established a Pre-kindergarten Education Pilot Program for the 2021-22 school year. The City will provide a stipend in the amount of up to \$2,700.00 per school year, to cover up to an additional 450 instructional hours of instruction (up to 2.5 hours per day for 180 days, payable on a non-deductible basis). Program Instructional Hours may only be applied toward programming occurring during the regular school hours for PreK Education Program. Applications were accepted until January 4, 2021. The lottery was held on January 5, 2021.

PREK PROGRAM ELIGIBILITY

WHO is eligible for the PreK stipend:

Families who live in the City of Miami Beach and who have a child (any child 4 years old on or before Sept. 1, 2021) or has a lottery that falls between February 2, 2016 to September 1, 2017. The Parent/Guardian must be a resident of the City of Miami Beach upon submission of the application and throughout the 2021-2022 school year.

Program funding is limited, not all persons on the lottery waitlist will be contacted. Staff will contact applicants in the order of selection by a computerized lottery system which will establish a numerical order of service until all funds are exhausted. Results from the lottery will be posted on the City's website including my name, certification number, and lottery number.

Required Documentation:

Proof of City of Miami Beach Residency - At least one (1) document from the list of primary sources (bolded) and one (1) document from the list of secondary sources of documents (italicized below, when required)

Primary Sources of Proof of Residency (At least 1)

- Valid Photo ID issued by local, state (Driver's license)
- Valid Photo ID issued by federal agency (Passport)

Secondary Sources of Proof of Residency (One (1) of the following monthly statements with the resident's name and address that has been stated within the last 30 days)

- Utility bill (EPL, phone, gas, cable)
- Cell phone bill
- Bank statement
- Credit card statement
- Vehicle insurance bill
- Mortgage statement
- Property tax statement (last one received)
- Voter registration

Note: Internet/Electronic bills are not acceptable proof of domicile.

Proof of Child's Age - At least one (1) of the following documents will be required:

- an original or certified copy of the child's birth record according to law with the appropriate public official
- an original or certified copy of the child's certificate of baptism or other religious record of the child's birth, accompanied by a notarized affidavit stating that the certificate is true and correct, sworn to or affirmed by the child's parent
- an insurance policy on the child's life which has been in force for at least two years
- a passport or certificate of the child's arrival in the United States
- an immunization record signed by a public health officer or licensed practicing physician, or
- a valid military dependent identification card or a federal or state government issued identification card

PROVIDER

Who is Eligible to be a PreK Provider?

To be eligible to deliver the CMG PreK Program services, Provider must be a traditional public school or unincorporated (the following include PK Education Program applicants): (1) a child care licensee licensed under Section 402.305, Florida Statutes; a family day care licensee licensed under Section 402.313, Florida Statutes; an unlicensed large family child care licensed under Section 402.313, Florida Statutes; or individuals who are licensed or unlicensed under Section 402.302(2)(a) or a faith-based child care licensee licensed under Section 402.306, Florida Statutes.

The City is responsible for determining eligibility of Provider to participate in the CMG Program. The City will provide confirmation of eligibility received from the City's Chief Financial Officer.

The City will provide a stipend to cover up to an additional 450 instructional hours. The Program Instructional Hours may not be used to support or duplicate funding provided by Third Party Funders which is received by the participants. The Program Instructional Hours may be used to address additional PreK Education Program hours beyond those funded through Third Party Funders, or they may be used otherwise.

Payment Note: Provider will be eligible to receive payment for eligible Program Instructional Hours of services provided during the 2021-22 school year of \$6.00 per hour, whichever is less, for up to 2.5 hours per day for 180 days, not to exceed \$2,700 per application school year per participating child. Any amount received or received on behalf of Provider offerings available for the school year will be delivered to the amount due from the City as appropriate.
