This letter is to express my interest for the position of City Manager for the City of Miami Beach as recently advertised.

Attached you will find my resume that highlights certain aspects of my career, all of which meet or exceed the traits expected of a progressive City Manager. I am sure that by this point you are receiving resumes and letters of interest from many viable candidates. While many of these candidates are undoubtedly well qualified, I can assure you that few can offer the variety and well-rounded experiences I would bring to the City of Miami Beach. Aside from 25 years' experience in Law Enforcement, I bring forth experience in all fields of Emergency Services (as both a Firefighter and a Paramedic), by way of both volunteer and paid services. My formal education is highlighted by attaining my Master's Degree and completion of the Certified Public Manager Program as well as countless work-related training programs on the topic of Management and Supervision. Most recently, I have continued my educational path towards earning my Ph.D. in Public Policy and Management. Additionally, I am also an Adjunct Faculty member for Fairleigh Dickinson University, where I teach Graduate level classes in Management and Supervision.

My law enforcement position had enabled me to gain the experience of initiating new projects, while managing a highly technical unit as well as acting as a liaison to our Community Policing Program. My experiences span government administration, investigative work, inventory control, personnel instruction, training, policy and procedure development, law enforcement and emergency operations functions, and management operations of a governmental entity. I have been involved in labor relations and budgeting in addition to extensive grant management experience. Most of my law enforcement tenure was spent in an investigative and supervisory capacity requiring interaction with persons from all walks of life. Interaction with public spanning from various professionals to those with little or no education were accomplished daily, through delivery of excellent customer service.

My experience as a small business owner has given me the unique perspective to be more fiscally responsible to the taxpayer and various stakeholders of an agency, through practicing personnel management and cost analysis. Through my various employment positions and holding elected office, I have learned to navigate through a political environment requiring the ability to provide guidance to an elected body even when the proper recommendation may not always be the popular one.

Currently, I am serving in the capacity of Township Manager for Howell Township NJ. Howell Township is a 61-square mile town with a population of almost 60,000 residents and a \$54,000,000 operating budget and a \$7,200,000 Sewer Utility budget. During my tenure as a Manager, and previously as an Administrator, I have initiated several new programs that lend themselves to cost savings, efficient operations through inter-local agreements, and initiatives that mutually benefit the municipality's coffers and our local businesses, even terminating Shared Service Agreements after determining they were no longer cost effective. During previous positions, guiding the Municipality's recovery through the aftermath of 'Hurricane Sandy', has led to an increase in recovered funding, through managing extensive insurance claims and FEMA reimbursements. Each town where I have worked has owned and operated its own Sewer Utility, managed under the Manager/Administrator.

Based upon the needs of City of Miami Beach, I bring extensive experiences in General Administration, and all facets of Emergency Services including, Police, and Fire as well as Emergency Medical Services (not listed in resume, as I maintain EMT-Paramedic certification). I also have experience in Finance and Labor Relations, as well as navigating the FEMA process of disaster recovery. Furthermore, I am an elected Fire Commissioner in Toms River, overseeing an operating budget of over 3 million dollars, and have implemented cost savings that reduced our overall budget by 10% in one year, without any reduction in services. Furthermore, I volunteer for a non-profit by serving on the Board of Directors of Silverton Emergency Medical Services.

If selected for this position, I can offer a unique, potential cost savings measure to the City through potential waivers of healthcare and/or pension contributions, if available. I am a member to the International City/County Management Association and have contributed to the field of Management through my position as an Adjunct Faculty member of Fairleigh Dickinson University and mentoring other retired Law Enforcement Officers seeking to transition to a Manager/Administrator position. As required by the listing, my current annual salary is \$188,440. The Township provides a 10% match to a deferred compensation account, the use of a vehicle; and although offered, I do not receive health insurance benefits from Howell Township. My employment agreement is currently being re-negotiated.

In closing, I believe that you would agree that my combined experiences in both the public and private sectors, combined with my formal education would make me a viable candidate for the position of City Manager. I look forward to the opportunity to move forward in your selection process. I thank you for allowing me this moment to introduce myself and look forward to proving myself worthy of being an asset to the staff and stakeholders of the City of Miami Beach.
