ASSUMPTION OF RISK & WAIVER OF LIABILITY RELATING TO CORONAVIRUS / COVID-19 – Ocean Rescue Jr. Lifeguard Camp

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend physical distancing and have, in many locations, prohibited the congregation of groups and people.

The City of Miami Beach (City) has put in place preventative measures to reduce the spread of COVID-19; however, the City cannot guarantee that you, your children, or any other person, will not become infected with COVID-19. Further, attending City sponsored activities could increase your risk and your child or children's risk of contracting COVID-19.

Mitigation strategies in order to reduce / prevent the spread of COVID-19 include, but are not limited to, the following:

- No signs or symptoms of COVID-19 in the past 14 days. If a person has a documented case of the COVID-19 infection, a doctor's note is needed to clear to participate in training sessions after the applicable period of quarantine for 14 days. If the child is sick, he/she must stay at home. If the child has been in close contact with someone infected with COVID-19 in the last 14 days, the child must stay home.
- You must maintain normal temperature readings, temperature checks should be conducted by participants and their families each day prior to camp.
- Coaches and/or City Staff will ask each participant if they are experiencing any signs or symptoms of COVID-19. If the athlete shows any signs or symptoms of infection, they will be sent home and need to contact a healthcare provider.
- Each player is responsible for having their own infection prevention supplies to be utilized, such as hand sanitizer and facial covering. Children will be expected to use hand sanitizer before and after practice.
- Participants will practice social distancing, place bags, and equipment at least 6 feet apart. Children will be in small groups per activity to avoid big gatherings and will maintain social distancing within a group.
- Each child must have their own snack and water bottle (brought from home) and will not be permitted to share with another child. Water bottle can be refilled at camp.
- No high fives, huddling, hugging, group celebrations, spitting or coughing. Participants will arrive dressed with appropriate attire for the camp with masks which can only be taken off at the start of daily activities.
- Coaches will wear masks during all sessions with the exception when being in the water.
- Ocean Rescue is to clean and rinse off equipment every day after camp is done.

- Parents are expected to drop off and pick up children only.
- Parents are to notify the Ocean Rescue personnel immediately if your child becomes sick for any reason.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child or children and I may be exposed to or infected by COVID-19 by attending City activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at City activities may result from the actions, omissions, or negligence of myself and others, including but not limited to City employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child or children or myself, including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense or any kind, that I or my child or children may experience or incur in connection with my child or children's attendance at City activities or programming. On my behalf and on behalf of my child or children, I hereby release, covenant not to sue, discharge, and hold harmless and indemnify the City, its employees, agents, and representatives, of and from any and all claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the City, its employees, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any City program. Furthermore, I consent for my child's temperature to be taken at any time staff members feel it is necessary.
