Subject: Prekindergarten Pilot Program Provider Information Sessions

The purpose of this Letter to Commission is to update you on the status of the City of Miami Beach's Prekindergarten (PreK) Pilot Program for Miami Beach residents for the 2021-2022 school year, approved at the July 29, 2020 Commission meeting. The Prekindergarten Pilot Program will expand hourly access to PreK by increasing options to high quality providers by providing up to \$2,700 to eligible Miami Beach families.
