Support Services

The City of Miami Beach Office of Housing and Community Services focuses on providing referral services-including rental, mortgage, and utility assistance to income-eligible residents. The City also provides a grocery delivery program to elderly individuals experiencing food insecurity. Additionally, the City owns and operates 89 units of affordable housing and maintains a waitlist for the units. In 2023, the City awarded Legal Services of Greater Miami \$183,801 in HOME-American Rescue Plan funds for the Tenant Defense project, which can assist Miami Beach residents facing evictions and other housing issues with legal counsel.

Other Accomplishments

The Office of Housing and Community Services continues to collaborate with the Office of Marketing and Communications to promote the SHIP program through various social media platforms. The City continues to combine SHIP and HOME funds to increase the award amounts for applicants.

Provide a description of efforts to reduce homelessness:

The City has established relationships with a variety of agencies within the Continuum of Care to provide access to emergency housing via the referral and placement process to improve client access to emergency shelter and transitional housing. While most major metropolitan cities face shelter shortages and often turn homeless people away because of space constraints, the City of Miami Beach has had an average daily shelter vacancy rate of 32 beds. Staff identifies the core service needs of a homeless person and issues referrals to the agencies that best fit his/her need. In doing so, the City has established the following relationships with shelter providers:

- 20 City-funded beds at The Salvation Army for men, women, and children with Care Coordination provided by the agency to assist clients on their path to independence.
- 15 City-funded beds at the Miami Rescue Mission for men with Care Coordination provided by members of the City's Homeless Outreach Team to assist clients on their path to independence.
- 12 City-funded beds at Camillus House for men with Care Coordination provided by the agency to assist clients on their path to independence.
- An additional 40 traditional shelter beds are made available at various shelters throughout Miami-Dade County via funding from the Miami-Dade County Homeless Trust.

The City's Homeless Outreach Services Program provides a variety of services to help people end their personal homelessness, including shelter placement, family reunification, identification replacement, and community referrals.

From July 1, 2020- June 30, 2021, 713 homeless persons passed through our City, encountered by the City's Homeless Outreach Services Team and Miami Beach Police Department. The City's Homeless Outreach Services Division provided the following services:

- o 358 emergency shelter placements;
- o 41 Birth/Naturalization certificate replacements;
- o 87 homeless people were relocated to other cities or states to reunite with family or friends;
- o Specialized outreach and medication management to homeless persons who are severely and persistently mentally ill via the Camillus House Lazarus Project; and
- o Continuous Street outreach and community engagement to homeless persons who were unsheltered or at imminent risk of losing shelter.
