Flamingo Park Handball Courts

Project Update - February 1, 2022

The City of Miami Beach is nearing completion of construction work on the Robert Haas Handball Courts. We expect the project to be finished in its entirety by March 2022 after we complete final fixes and floor repairs to the Joe Rubin courts.

What's Happening

The city has achieved substantial completion of the Flamingo Park Handball Courts project. While we are excited to finally reach this milestone, we want to wait until all punch list work items are complete before hosting a grand opening event to present the new courts to the Miami Beach community.



The remaining punch list work entails fixing minor items throughout the project limits and repairing the floors on the Joe Rubin courts. During this process there will be some temporary closures of the Joe Rubin courts. Two courts are scheduled for closure on Feb. 2 and approximately two weeks later, all of the Joe Rubin courts will be closed. This closure will last approximately three weeks (dates on diagram are approximate). We thank you in advance for your patience and cooperation as we work to deliver this wonderful, long-awaited project to the players and Miami Beach community.

During the temporary closures of the Joe Rubin courts, the Robert Haas courts will be open for play. Please use the courts at Palm Island Park as an alternate. That park is located at 159 Palm Ave.

Project Overview and Benefits

Flamingo Park spans more than 36 acres in South Beach. As funding becomes available, the city will continue to upgrade park amenities to enhance public enjoyment. As various sections of the master plan are completed, residents and visitors will have renovated and new amenities at Flamingo Park to make playtime more fun and functional.

What to Expect

- Work hours are weekdays from 8 a.m. to 6 p.m. Extended time is subject to city approval. Work is scheduled to take place on some Saturdays from 10 a.m. to 4 p.m.
- Handball players will be able to access the newly renovated Haas courts (diagram included)
- Please note, schedules can change due to inclement weather or unforeseen circumstances.
- Temporary closures of some handball courts will be in place for approximately one month.
- Construction fencing will be altered to frame the new work zone.
- The dog parks should not be impacted by this work.
- Notices were posted at the Flamingo Park handball courts in advance of the temporary closures.
- Parking restrictions may be posted near the construction zone entrances. Please adhere to posted signage to avoid enforcement measures.
