- If you have a proxy attending the Lottery on your behalf, you must write a letter stating your name and your proxy's name. This letter must be notarized and returned to the Customer Service Center no later than 24 hours prior to the Lottery (9:00 a.m. Monday morning before the Lottery on Tuesday).
- All Artist Vendor Certificates (ID's) must be renewed and paid at least 24 hours before the lottery date for the lottery quarter you have applied for. Failure to do so will disqualify you from participating in the lottery.
- All Code violations must be paid prior to the Lottery date.
- Proper photo ID is required to pick up the Permit. Only you (the applicant) can pick up the Lottery permit.

Please have everything paid and turned in 24 hours prior to the Lottery to participate.
